RESOLUTION NO. 2017 - 1

A RESOLUTION OF THE CITY OF PAUL, MINIDOKA COUNTY, IDAHO, ESTABLISHING RATES FOR THE DELIVERY OF WATER WITHIN THE CITY LIMITS; RATES FOR THE DELIVERY OF WATER AND HOOKING UP TO THE WATER SYSTEM OUTSIDE OF THE CITY LIMITS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council reviewed the rates charged for the delivery of water, and

WHEREAS, notice of the proposed fee increases was published in the Twin Falls Times News two (2) times prior to the regular council meeting held on April 12, 2017, and

WHEREAS, a public hearing on the proposed fee increases was held at the regular council meeting on April 12, 2017, and

WHEREAS, it appears to the Council that an adjustment in rates is necessary, and

UPON motion made, seconded and carried:

IT IS RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF PAUL, IDAHO, THAT:

Section 1: Pursuant the grant of authority in Paul City Code § 6-3A-7-1, the amount to be charged and collected for delivery of water through the city's culinary water system shall be as follows:

1.1. For water delivered during the months of October, November, December, January, February, March and April:

For delivery to customers having a meter size exceeding 2" the Public Works Director shall establish a rate based upon his estimate of the amount of water delivered taking into account the size of the meter. Should any customer dispute the amount charged by the Public Works Director, the customer, upon written request, shall be entitled to review of the charges by the City Council at a regularly scheduled Council meeting.

1.2. For water delivered during the months of May, June, July, August, and September, the rate charged will be a base rate plus a rate based upon metered water usage as follows:

For delivery to customers having a meter size exceeding 2", the Public Works Director shall establish a base rate, a maximum delivery charge for the base rate, and a cost per gallon exceeding the base rate. Should any customer dispute the rate established by the Public Works Director, the customer, upon written request, shall be entitled to review of the rate by the City Council at a regularly scheduled Council meeting.

Notwithstanding the foregoing, the water bill for a 3/4" water meter connection shall not exceed \$51.00 \$56.00 per month.

Section 2: The rates for water hookup and for delivery of culinary water outside of the city limits shall be $1\frac{1}{2}$ times the applicable rate.

Section 3: These rates and charges shall go into effect May 1, 2017.
